Payment Information:

Unique Concessions requires a 50% deposit and signed contract from the client to reserve the date of the event. The balance of the contract is due 3 weeks prior to event date, if client has not paid balance of contract in full 3 weeks prior to event date, we will not guarantee the services agreed upon that the client has requested. Payments can be made by cash, check or credit card.

(note if paying with cash a discount will be applied).

If client requests cancelation of services after a signed contract, 20% of total package fee will be applied.

Responsibility of client:

Client accepts responsibility and is liable for any damages or injuries that occur as a result of failure to comply with these provisions.

Liability: Client agrees to assume full responsibility and liability for any and all claims arising out of the use of our services or attendants of Unique Concessions.

Unique Concessions will not be liable for any injury, allergic reaction, loss or damage directly or consequently arising out of the use of rental buffets or carts.

Client indemnify Unique Concessions harmless from all claims, actions, proceedings ,costs, damages and liability including attorney fees and court costs arising out of or in connection with or resulting from the services of Unique Concessions.

Damage or Stolen Equipment:

In the event that the equipment or properties of Unique Concessions is damaged in any way due to the misuse from client or their guests, The client agrees to pay all repair costs up to and including full replacement of equipment belonging to Unique Concessions.
